The DRP was approved by the shareholders of Maybank at the extraordinary general meeting held on 14 May 2010. On 25 August 2022, the Board of Directors of Maybank ("Board") declared a single-tier first interim dividend in respect of the financial year ending 31 December 2022 of RM0.28 per Maybank Share held ("First Interim Dividend").
